When we receive your Affidavit of Support fee, we will send you the Affidavit of Support (I-864) forms and further instructions.

## Important Notes:

- Do not send a personal or attorney/firm check(s).
- If you wish to send your payment via an overnight mail courier service, please note that only the U.S. Postal Service provides such delivery service to post office boxes.
- Do NOT send any payments to the Portsmouth, NH address, as they will be returned to you.

- Send only the payment and fee bill to the St. Louis, MO address.
- Do not send any other documents to the St. Louis, MO address.
- Do not send any documents to the Portsmouth, NH address until you are requested to do so.

# Affidavit of Support (I-864) Processing Fee Bill

## Instructions:

## How much to pay:

The Affidavit of Support (I-864) processing fee is \$70.00 U.S. per case.\*

\*Exceptions: If you are a U.S. citizen filing a separate Affidavit of Support (I-864) for your spouse and children to immigrate, you only need to submit one\$70.00 fee, which will cover your spouse and children. If you are a U.S. citizen filing a separate Affidavit of Support (1-864) for each of your parents to immigrate, you only need to submit one \$70.00 fee, which will cover both parents. (Please mail all fee bills in one return envelope with one check on top.)

### What to send:

- 1. A cashier's check or money order in U.S. dollars, drawn on a U.S. bank, made payable to the Department of State with the case number (shown below) written on the front of the check. Do NOT send cash, a personal or attorney/firm check.
- 2. The Bottom of this Page (the tearoff of this page is required to avoid delays in processing this case)

DO NOT SEND ANY I-864 FORMS NOW, as they will be sent to you once this fee has been paid. Sending the I-864 form now will cause delays processing your case.

Please note: Fees are non-refundable.

# Information about the Choice of Agent and Address Form

Unless an adjustment of status in the United States is requested, after approving an immigrant visa petition filed in the United States, the U.S Citizenship and Immigration Service (CISformerly known as the INS), forwards it to the National Visa Center (NVC) where the State Department's immigrant visa process begins. If the petition is for a visa applicant whose priority date is not likely to be reached in the next year, the petition will be stored at the NVC until that priority date is reached.

When there is an immediate visa available or likely to be available within the next nine months, the NVC will send a letter enclosing the Choice of Agent and Address Form (DS 3032) to almost all of the applicants for immigrant visas. The DS 3032 is not required and will not be sent to the applicant when an attorney represents the applicant (and the CIS file contains the appropriate form that an attorney has been retained) or when the visa applicant will be the adopted child of the petitioner.

The DS 3032 permits the applicant to name an agent to receive correspondence from NVC and requires applicants still interested in immigrating to tell NVC where to send mail about their visa request. The letter tells the applicant that they may choose someone, including the petitioner or a helpful organization, to be their agent or they may elect to continue to receive the correspondence themselves. The applicant must complete and sign the DS 3032 and return it to the NVC before processing can continue. Given the difficulties often encountered with international mail, we **encourage** applicants to seek an agent with a U.S. postal address.

So that you may understand any questions that the applicant may have about the DS 3032, we have enclosed a copy of it for you. *Only* the applicant can sign the DS 3032, but you may send or fax a copy of the enclosed form to the applicant, if you learn that he or she has not received it. The applicant can then complete, sign, and return the DS 3032 to NVC. The mailing address for the DS 3032 is:


