Dear Sir or Madam:

My name is 00000, and I am the former wife of 00000. I am writing this letter in regard to Mr. 00000's VISA/Green Card.

00000 and I first discovered each other through a Christian online dating website in the summer of 2007. He claimed to be a Baptist preacher/missionary and I was very attracted to him because of his interest in serving the Lord. 00000 was very persistent during our "online courtship" and even stated in a number of letters that he loved me. Looking back now the red flags were very evident, but I stubbornly refused to acknowledge them. I met 00000 in person on January 1, 2008 and his persistence created a number of incidences wherein I had to literally push him off me and threaten to scream for help. Why did I continue to entertain the thought of being in a relationship with such a person? I cannot answer this because I'm not even sure of the answer. What I can tell you is that we were married on February 21, 2008 which was 52 days after our initial first date. I have since paid a heavy price for this very foolish and compulsive mistake. We were together as husband and wife for approximately thirteen months and it was the most miserable period in my life and in the life of my family.

I married 00000 for the purpose of being a wife to him; going with him to the Philippines as a missionary couple; and for starting our own family together. At the time of our marriage I did not know that 00000 was in the USA illegally or that he had lied about numerous legal, ethical and moral matters. I believe that 00000 doggedly pursued me knowing full well that he was an illegal alien, unemployed, without transportation, without much money, and living in North Carolina on borrowed time. He also knew of my sincere desire to do what was right and to live a clean and Godly life. In his eyes I was the perfect candidate for marriage. I was trustworthy, faithful, responsible, intelligent and eager to be a preacher's wife. He was in desperate need of a wife to showcase to his supporting

churches that he was a "family man" so that his ministry support would be increased and so that he could expand his "ministry" by networking from preacher to preacher. In other words, 00000 did not marry me for love.

There is so much information that I could provide to you regarding the amount of money 00000 has admitted to taking from his supporting churches, how he operates, as well as his conduct throughout our marriage. He has never once considered how his actions have truly affected me, his other victims, my family, etc... I am not going to go into details right now of all that I know and have learned about 00000 because it would take many pages of explanation. What I want you to know is that I have been to see a number of counselors regarding this matter and they all agree that 00000 has serious psychological problems. All of them agree that he exhibits psychopathic and sociopathic personality disorders. He is a habitual liar and he has no consideration for others. He will do whatever it takes to get whatever he wants. 00000 can be very charming and sweet. His personality along with his clean cut appearance gives the impression that he is harmless; however, this is all a façade and a guise. It would appear that 00000 has perfected his art at fooling everyone he knows, but if you spend a little time with him it will become evident that there is something "irregular" about him.

I became pregnant in December, 2008. By this time in our marriage I had already been hospitalized twice. 00000 wrung me dry financially and emotionally. My relationship with him was causing me a lot of health issues and I was on the verge of having a miscarriage. My counselors were very concerned and advised me to leave him immediately, file a restraining order, to move to an undisclosed location, and not tell 00000 when the baby was born or what his name was. I followed their advice, as well as filed for and received a judicial separation wherein the Judge ordered 00000 to leave me alone. Throughout all of this I was able to sustain the pregnancy. 00000 was born on August 23, 2009. My little boy is my constant joy and the most precious thing in my life. I did my best to cease all contact with 00000, but he hired a private detective and had me served with papers approximately four weeks after giving birth. Right now 00000 is getting supervised visitation (I have full custody) with our son; however, I am afraid of him. I know that his is still really angry that I kept the baby from him and didn't let him take part in his birth. He is capable of hurting me and/or 00000. I divorced 00000 on June 1, 2010, and he is angry about this as well. In fact, he tried to prevent the divorce from going through.

Please read and reread this letter. If you have any questions or if you would like to interview me or talk with my counselors, any of us would be willing to do so. My purpose in writing this letter is that I want 00000 deported back to his country. He will continue to wreak havoc on my life, 00000's life and the lives of his other victims if he is not sent away. Thank you for taking this into consideration. I appreciate your time.
