To prepare for your interview appointment with a consular officer, please read and follow carefully the instructions below.

You must complete the following two forms, print them and bring with you on your interview day:

Forms DS-160, Nonimmigrant Visa Application (**online application form**)

Form DS-156K, Nonimmigrant Fiancé Visa Application

If your children will apply with you, one copy of Form DS-160 for each child must be completed in full.

Obtain the following documents on this checklist which pertain to you. Do NOT send them to this office, **NOTE:** The documents listed are required for both your nonimmigrant visa and the U.S. Immigration authorities when you apply for permanent residence status.

**PASSPORT:** A passport must be valid for travel to the United States and must have at least six months validity beyond the issuance date of the visa + 1 copy.

**BIRTH CERTIFICATE:** Original birth certificate plus translation (if not in English) + 1 copy of each.

**UNOBTAINABLE BIRTH CERTIFICATES:** If an official birth certificate is not obtainable, present the best possible secondary evidence, such as a baptismal certificate, hospital certificate, school records, and/or a notarized affidavit from your parents.

**DIVORCE/DEATH CERTIFICATE:** Original Divorce/Death certificate (if applicable) plus translation (if not in English) + 1 copy of each.

**EVIDENCE OF RELATIONSHIP:** You will be asked to submit evidence that you have previously met your fiancé (e), and proof of a valid fiancé (e) relationship with your petitioner. It is, therefore, useful to bring with you letters, photographs, or other evidence of your engagement.

**POLICE RECORDS:** Each applicant aged 16 years or over is required to submit a certificate from the appropriate judicial or police authorities from the country of the applicant's nationality and/or current residence where the applicant has resided for at least six months since attaining the age of sixteen, **as well as from all other countries where the applicant resided for at least six months since attaining the age of sixteen.** For countries maintaining national police records, a certificate from the national police or judicial authorities must be submitted. For countries not maintaining national police records, a certificate must be obtained from each locality. A police certificate must also be obtained from the police authorities of any place where the applicant has been arrested for any reason, regardless of the length of residence. Police records from certain countries are considered unobtainable. If not in English, it must be translated.

**COURT AND PRISON RECORDS:** Persons convicted of a crime must obtain a certified copy of each court record and any prison record, regardless that they may have benefited from an amnesty or pardon. If not in English, it must be translated.

**MILITARY RECORDS:** A certified copy of any military record (if applicable) plus translation (if not in English) + 1 copy of each.

**EVIDENCE OF SUPPORT:** Evidence which will show that you are not likely to become public charge in the United States. An affidavit of support **Form I-134** should be completed by the petitioner and submitted with all supporting documents - current salary letter, current bank statement and 1040 tax form for the most recent year. A joint sponsor would also be required if the petitioner is unemployed. **Originals, not photocopies, of these documents must be brought.**

**MEDICAL EXAMINATION:** Follow the instructions on the attached instruction sheet for obtaining a medical examination. This medical examination will also be accepted by the U.S. Immigration and Naturalization Service for adjustment of status to lawful permanent residence.

**PHOTOGRAPHS:** Two (2) colored photographs, white background, 2"x2" and must be showing full face of the applicant, are required.

**FEES:** Visa application fee \$ 265 and must be paid in cash at the US Embassy in Abu Dhabi on the day of your visa interview appointment.

You must provide the Hospital with your original passport + one copy, 2 photos and your vaccination records.



## Security Information

The following items are **PROHIBITED** and cannot be brought on to the premises. Persons carrying any of the items mentioned below will be **denied entry** to Embassy/Consulate facilities. Leave all such items either at home or hotel room, or with a friend or relative who remains outside the premises.



**NO BAGGAGE-** To facilitate and speed up your entry into the Embassy/Consulate **DO NOT** bring baggage. Persons with large bags will not be admitted.



**REMOVE all metallic items and put them in a box for screening**, together with your coat/jacket, belt, handbag/briefcase, etc. **In addition**, since you will need to go through a metal detector, avoid wearing clothing with metal element.



**UMBRELLAS CANNOT be taken** on to the compound.



**NO CELL PHONES-** To avoid being denied entry to the Embassy/Consular facilities **DO NOT** bring cell phones with you. You will be turned away!



**ELECTRICAL, ELECTRONIC or BATTERY-OPERATED ITEMS** – including, **but not limited to:** computers, laptops, music playback devices such as Walkman, CD, DVD, MP3, iPods, palm pilots, USB sticks, cameras, video cameras, calculators, hairdryers and shavers, game boys, electric toys, etc.



**LIQUIDS, CHEMICALS and GASSES** - Including all compressed air canisters or dispensers for mace or tear gas of any kind, hairsprays, deodorant sprays, cleaning chemicals and consumable liquids. Should you wish to bring baby food, then this would need to be filled into a plastic container. **Essential medical items or equipment may be brought in upon specific request.**



**FIREARMS AND WEAPONS** - Including replica or non-firing weapons, blank or starter pistols, tear gas pistols, and stun guns; knives of all kinds, swords, scissors, cutting tools and straight razors.




**EXPLOSIVES** - Including fireworks, smoke bombs, pyrotechnic devices or flares, and flare guns or launchers.


**YOUR COOPERATION WILL HELP TO ENSURE EVERYONE'S SAFETY AND ALSO GUARANTEE THAT YOU WILL BE ON THE PREMISES AS EXPEDITIOUSLY AS POSSIBLE FOR YOUR APPOINTMENT.**

موارد زیر **ممنوع** هستند و نمیتوان آنها را وارد محوطه کرد. افراد حامل هر کدام از موارد ذکر شده در زیر **از ورود به محوطه سفارت/ کنسولگری محروم خواهند شد**. تمام این موارد را در خانه و یا هتل و یا همراه یک آشنا و یا فامیلی که وارد محوطه نخواهد شد ترک کنید.


**چمدان/کیف ممنوع میباشد**- به منظور تسهیل و سرعت بخشیدن به ورود به سفارت، آوردن چمدان و کیف **ممنوع است**. افرادی که ساک بزرگ همراه دارند پذیرفته نخواهند شد. 


همهٔ موارد فلزی را بردارید و آنها را برای بازرسی در یک جعبه بگذارید، به همراه کُت/ژاکت، کمر بند، کیف/کیف دستی و غیره .... علاوه بر این از آنجایی که نیاز است شما از یک فلزیاب عبور کنید از پوشش لباس با عناصر فلزی اجتناب کنید.

تلفن همراه ممنوع است- برای جلوگیری از محرومیت شما از ورود به محوطه سفارت/کنسولگری تلفن همراه را با خود نیاورید. از ورود ممنوع خواهید شد! 

لوازم برقی، الکترونیکی و وسائلی که با باتری کار میکنند- از جمله اما نه محدود به کامپیوتر، لپ تاپ، دستگاههای پخش موسیقی مانند واکمن، iPods، MP3، DVD، CD، حافظه USB، دوربین، دوربینهای ویدیویی، ماشین حساب، ششوار، ریش تراش، اسباب بازیهای الکتریکی و غیره. 

مایعات، مواد شیمیایی و گازها- از جمله تمام قوطیهای هوای فشرده و یا دستگاههای MACE و یا هر نوع گاز اشک آور، اسپری مو، اسپری عطر، مواد شیمیایی تمیز کننده و مایعات نوشیدنی. چنانچه خوراک برای نوزاد میاورید، آن را باید در ظرف پلاستیکی بگذارید. لوازم و تجهیزات ضروری پزشکی ممکن است بنا به درخواست خاص آورده شود. 

سلاح گرم و سلاح- از جمله ماکت و یا سلاح غیر شلیک، تپانچه خالی و یا استارتتر، تپانچه گاز اشک آور، تفنگ بیحسی، هر نو چاقو، شمشیر، قیچی، ابزار برش و تیغ. 

مواد منفجره- از جمله آتش بازی، بمبهای دود، دستگاههای آتش بازی و یا شعله، سلاح شعله و یا پرتاب کننده. 

**همکاری شما ضامن امنیت همگانی خواهد بود، و حتی المقدور ورود شما را به محوطه برای وقت مصاحبه تسریع خواهد داد.**
