- American Express Statement for the closing date between June 26, 2020 and October 27, 2020 - There is very little activity and the evidence is also limited to time period around the date of filing and do not establish a shared financial responsibility from the date of adjustment.
- Joint Lease Agreement for the period April 3, 2020 to April 2, 2021 - The evidence is also limited to the time period around the date of filing and does not establish a shared financial responsibility from the date of adjustment.
- Application for Certificate of Title dated April 20, 2019 - The evidence is also limited to the time period around the date of filing and does not establish a shared financial responsibility from the date of adjustment.
- Joint Auto Insurance for the period April 20, 2019 to March 15, 2020 - The evidence is also limited to the time period around the date of filing and does not establish a shared financial responsibility from the date of adjustment.
- Traditional IRA Application for [REDACTED] dated September 8, 2020 - This evidence does not establish a bona fide marriage.
- Google Fi account statement for Ivan Leon for the period between June 11 2018 and October 11, 2020 - This evidence do not establish a a bona fide marriage. The evidence is also limited to the time period around the date of filing and do not establish a shared financial responsibility from the date of adjustment.
- Huntsville Utilities bill for [REDACTED] for the period July 25, 2020 to August 19, 2020 - This evidence do not establish a a bona fide marriage. The evidence are also limited to the time period around the date of filing and do not establish a shared financial responsibility from the date of adjustment.
- Xfinity bill for [REDACTED] for the period April 17, 2020 and September 17, 2020 - This evidence do not establish a bona fide marriage. The evidence is also limited to the time period around the date of filing and does not establish a shared financial responsibility from the date of adjustment.
- BlueCross BlueSheild Health Insurance effective March 1, 2020 - The submitted evidence is limited to the time period around the date of filing and does not establish a shared financial responsibility from the date of adjustment.
- Guardian DentalGuard/Vision - There is no evidence of the effective date. If the effective date is the same as the health insurance, the evidence is limited to the time period around the date of filing and does not establish a shared financial responsibility from the date of adjustment.
- Copy of Costco membership cards - This evidence does not establish a bona fide marriage.
- Travel - This evidence does not establish a bona fide marriage.
