Payments for CAS fees are to be made payable to CAS via cash, check or credit card. Payments made via credit card are subject to a 2.7% processing fee. In the event a family is not able to proceed with their adoption plan, CAS will provide reimbursement of funds/fees paid for services in advance and not rendered. All such refunds shall be made within (60) days of non-receipt of services or completion of any service for which a refund is authorized. In situations where a refund cannot be provided, such as a donation or grant received over the total amount of an adoption, CAS will hold the financial credit so that it can be applied to another adoption for up to three years. If after three years, the surplus funds are not used, CAS will apply the monetary amount to the Woodward Scholarship fund.
