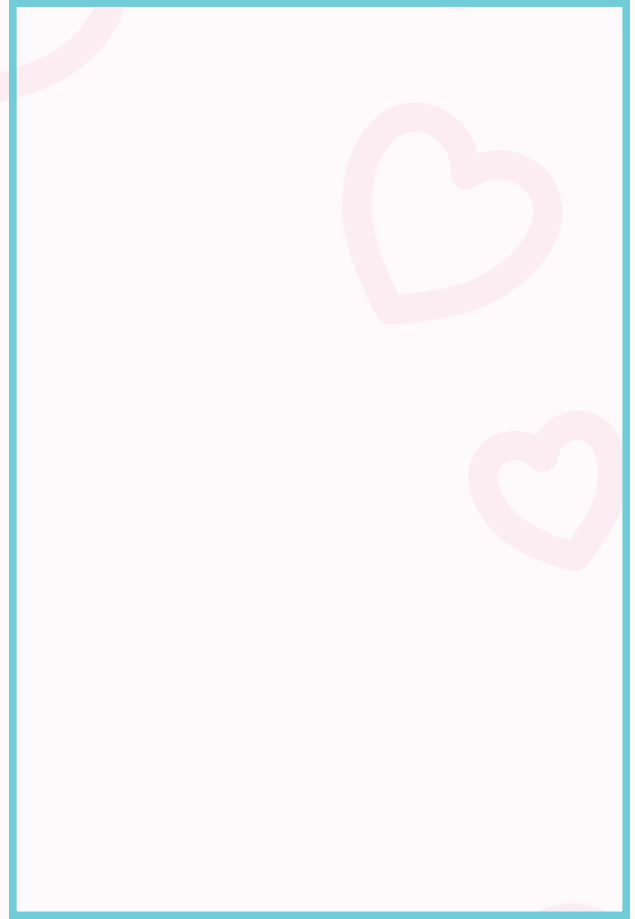
Enclosed in this packet I have included evidence that our marriage is bona fide and based on a loving relationship. I am hoping that the information provided will be of help.

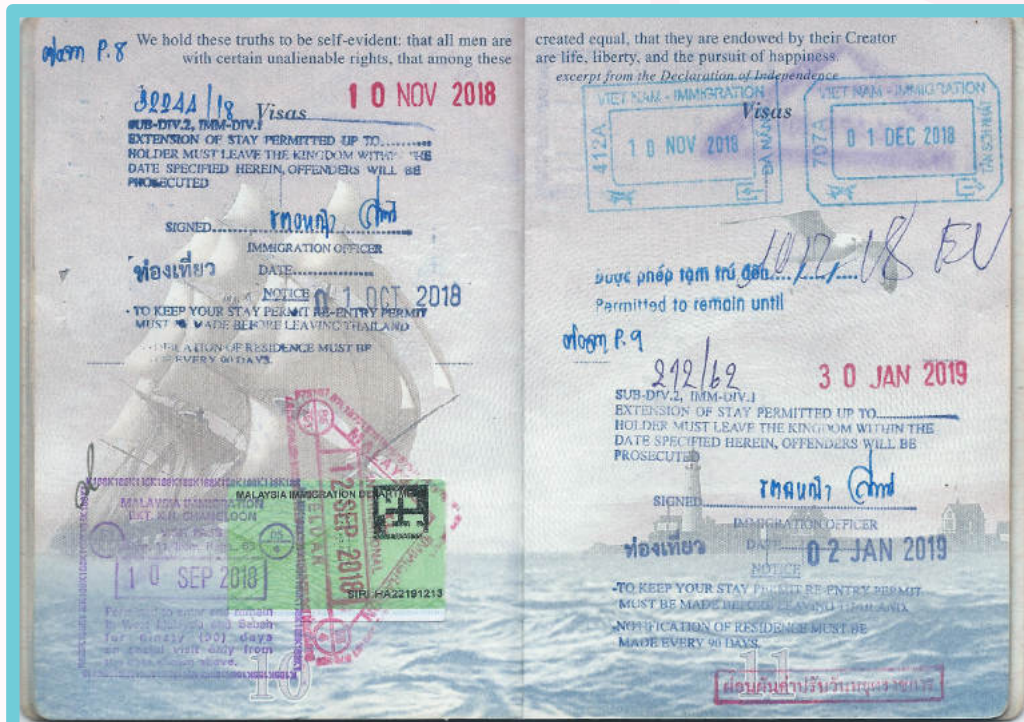
